

Three from Lenahan & Dempsey certified as specialists in Workers' Compensation law


In order to obtain this certification, attorneys must pass a rigorous screening process and examination and, according to the Pennsylvania Bar Association, the new test shows that the three from Lenahan & Dempsey, "...have successfully demonstrated the required level of skill, expertise and years of practice" to earn the new Workers' Compensation law specialist certification. "We are very proud of our Workers' Compensation practice which is anchored by Brian, Matt and Terrence," said Timothy Lenahan, managing partner of Lenahan & Dempsey. "To know they are among the first lawyers in Pennsylvania to earn this very prestigious professional certification shows what their clients already know - they are the go-to team for anyone who is injured at work."

According to the Pennsylvania Bar Association, applicants had to prove their qualifications to be allowed to take the test. Lawyers also had to show they have a minimum of 5 years of professional practice and devote at least half of their practice to Workers' Compensation Law. Lawyers were also required to have participated in at least seven different categories of Workers' Compensation cases over the past five years. The test itself was a five hour examination consisting of multiple choice questions on the intricacies of Workers' Compensation law as well as a written portion.

Matthew Dempsey joined Lenahan & Dempsey in 1981 following graduation from The University of Pittsburgh School of Law.
