

Truck Accidents In Northeastern And Central Pennsylvania

Our region unfortunately sees many tragic and preventable accidents caused by big trucks. Our region is home to an excellent highway system with Interstates 80, 81, 380 and 84 and the Pennsylvania Turnpike. These high volume roadways are also attractive to trucks as they are gateways to just about all major points, north, south, east and west across the United States.

In over 64 years of practice our office has seen far too many serious injury cases where truck drivers are speeding, or driving too many hours. The U.S. Department of Transportation Federal Motor Carrier Safety Administration also reports that 23% of large-truck crashes occur when these commercial vehicles are traveling too fast for the current road conditions. We also see cases where poor maintenance or poor training has also lead to very serious accidents.

The average tractor trailer is between 70 and 80 feet in length and fully loaded they can weigh up to 80,000 pounds (40 tons). Compare that to the weight of the average car on the road - 5,000 pounds. It's no wonder when trucks hit cars, it's the car that usually suffers far greater damage.

Accidents involving big trucks can be highly complicated. For instance, the tractor can be from one state and covered by one insurer, but the trailer can be owned by a different company from a different state with yet another insurer. The same goes for the driver, as well as the trucking company, inspection mechanics and others involved in truck maintenance.

If you or a loved one has been seriously injured in an accident involving a big truck, it is important you take a number of steps right away to protect your legal rights.
