For example, some people are of the belief the insurance company representing the person or company who injured them will always treat them fairly. Every seriously injured person needs to know insurance companies, while they have a responsibility to treat you fairly, often do not. Here's a recent example of a case here at Lenahan & Dempsey.

A young auto mechanic from Wyoming County area was seriously hurt in a car accident. He would need therapy, rehabilitation and faced the very real possibility of never being able to work again in his profession. While still in the hospital, an insurance company representative visited and tried to get him to accept a settlement of only \$10,000. The young man, unaware of all of his rights and all of the costs associated with his rehabilitation, almost accepted the offer. The young man and his family then asked me to take over the case.

I was able to negotiate a structured settlement that will guarantee the injured man a minimum of \$2.5 million and depending on inflation and tax issues, could rise to as much as \$3.3 million. The settlement will allow my client to get the medical care he may need for the rest of his life. It will help pay for adaptive equipment he may need to live independently. It will also financially support him while he is unable to work - perhaps for the remainder of his life.
